
- Retainer is paid as donation to the Illinois Hispanic Chamber of Commerce (IHCC) as donation;

Illinois Mexican and Mexican-American Students Initiative

TEP Impact

- 1. Democratize the process for Mexican students that wouldn't qualify for F-1 visas;
- 2. Provide financial stability through jobs + students complete their degrees in the U.S.
- 3. Self-sustainable fund (ISA)
 - ROI: Corporate clients access skilled talent + lowered wages.

UoC offered to develop the AI model for TEP, to help understand and predict data points on immigration, taxes, etc

Intl. Tax Strategy

Help Program's Feasibility and Attractiveness

- Develop network with trusted partners to support intl. Tax strategies for:
 - o Entrepreneurs;
 - Employers;
 - o Gov. policies.
- Tool development to facilitate trade

TEP Funding

Help Increase Access to Talent and Employers

- Fundraising for TEP ISA Workforce Development Fund (worldwide nationalities) - Ex: I-MMAS (Yr 1):
 - \$4.8m (100% refundable and considered donation)
 - 600 beneficiaries (\$8k retainer coverage)
 - \$2.4m+ in U.S. taxes (assuming avrg. \$40k salary)
 - *Employer ROI: ~50%(\$0 in tuition + ~50% wage savings YoY)
- Assistance in development TEP Entrepreneur Impact Fund Wabash Heartland IN Network (WHIN) fund model:
 - Retainer coverage (\$18k)
 - o 2x fund repayment through rev. sharing.

*Mid-level engineer salary in Chicago: \$80K
