#### **Fundamentals**

- Taxes = money that does not belong to you
- Filing properly: your responsibility
- Under the control of tax office
- And the public prosecutor

#### Criminal tax legislation

- Legislation needed (no decrees)
- Non bis in idem
- Protection of EU Charter of Fundamental Rights for VAT
- Protection of ECHR for all taxes

## Tax and criminal sanctions, a sliding scale

- You forget: tax+10%
- You think you're smart: +40%
- You set up a scheme: +80%,100% or more
- You do it again or you deliberately break the law: jail + fines etc
- VAT is particularly slippery

#### Criminal offences

- Misdemeanour: fixed fines per form not filed
- « General offence of tax fraud »
- Tax fraud laundering

#### Possible Sanctions

- Fines up to 600k
- Asset Freezing
- Imprisonment : up to 3 years
- Electronic tag
- Ineligibility
- Barred from managing a business
- Professional sanctions (lawyers, doctors etc)

#### Advisors at risk

- If 80%+ tax penalty incurred
- Advice must intentionally lead to fraud or laundering of proceeds
- 50% of fees derived from advice (min 10k)
- If accomplice : same sanctions
- Politicians are clearly less at risk:

#### Brief biography

- 90's: surgeon founder of an aesthetic clinic in Paris
- Technical advisor for Pharma
- 2005: Admits stealing Bucky, a 20keur guide-dog

- 2010-12: pdt of the Parliament's finance comittee

## All is well that ends (not) in jail

- ■3 years in jail ineligible 5y
- Appeal: 2 years + 2 years
   suspended 300k ineligible
   5y 3 luxury watches seized
- Note: no effective prison time, just an electronic tag
- Suspended by the « order of medical doctors » - 3 months

#### It's not the end of the world

- ■No election for 5 years (2018)
- Job in Cayenne (I swear it's true)
- Family house in Corsica
- Now a happy doctor in Ajaccio
- Ran for election again in 2024 and will run for mayor in 2026
